**Crating:** All dogs can crate inside all day at the trial.

**Masks:** Masks are not required inside the building as long as you are fully vaccinated (honor system). If you are not fully vaccinated, you must wear a mask that covers the nose and mouth all the time you are in the building including running your dog.

**Course maps:** We will e-mail you a PDF of the next day's course maps each evening after 6:00PM. The course maps will also be posted the wall close to the front door each morning.

**Results and Ribbons:** Results will be posted on the wall close to the front door.

Q Ribbons will be placed in an envelope with your name on it and hung on the wall by the office. Please leave the envelope so it can be reused. Placement ribbons will be on the table.

**Site Rules:** Please clean up after your Dogs, both at the site and at the hotels. Dogs are not permitted off leash outside the building or permitted on the neighboring business properties. Violators will be excused from the trial without refund.

**Parking:** Parking is allowed in the QC Dog Center lot, the auxiliary lot in back of the building, and on Saturday and Sunday also in the adjoining parking lot to the business next door (but not on the neighbor's grass or block the garage doors). Please do not park in the lot across the street. On street parking is also allowed, although there must be sufficient passage for required semi traffic.

**Lunch and Volunteering:** Lunch may be ordered for delivery by HyVee. Trial workers eat for free, and non-workers may order for \$7 (cash or check payable to QCDC). Orders are picked up approximately 10:30 am daily, and lunch is delivered around 12 pm.

**Directions to the trial site:

**From the North:** Take US 61 or I-88 to I-80 W, to I-280 E. Exit at Iowa Exit 4, West Locust St and turn right. Proceed one block to West Lake Blvd (at the Honda sign) and turn right.

**From East:** Take I-80 to I-74, to I-280 W, crossing the Mississippi River. Exit at Iowa Exit 4, West Locust St and turn left. Proceed one block to West Lake Blvd (Honda sign) and turn right.

**From South:** Take I-74 West to I-280 West, crossing the Mississippi River. Exit at Iowa Exit 4, West Locust St and turn left. Go one block to West Lake Blvd (at the Honda sign) and turn right.

**From West:** take I-80 East to I-280, follow to Exit 4, West Locust St and turn right. Proceed one block to West Lake Blvd (at the Honda sign) and turn right.

**Quad City Dog Center is at the end of West Lake Blvd across from the Honda plant.**
