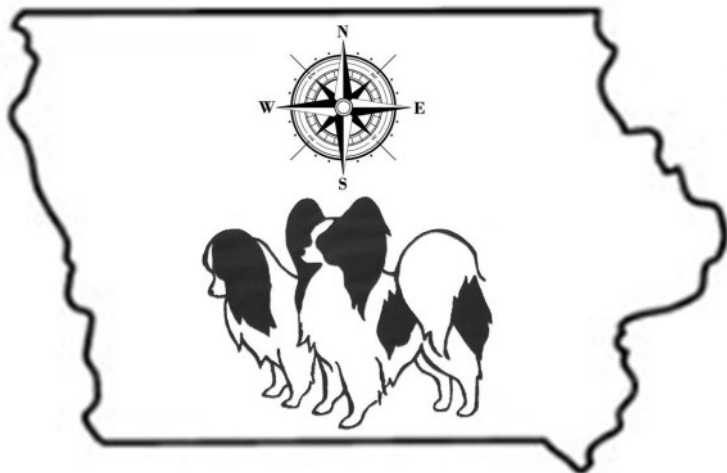

Riding with pets: In accordance with local and federal laws in your area, service animals are permitted to accompany riders at all times. If you're planning to ride with a non-service pet, it's good practice to contact the driver who accepts your ride request. Use your app to send a text message or call to let the driver know you'd like to bring a pet. Please help drivers keep vehicles clean for all riders by bringing a crate or blanket to reduce the risk of damage or mess. Some drivers may keep a blanket in the trunk.

Request when you're ready to walk outside.

Once you've gathered your baggage, choose a ride option that suits your group size, pricing and luggage storage needs.

Exit on the arrivals level.

From baggage claim, follow signs to the rideshare pickup area. This is where all Uber driver-partners at DSM to meet travelers for pickup.

Confirm your driver.

Always check that your driver's license plate matches what you see in the app. If you can't find your driver, contact him or her through the app.
